Beneficiaries:

At least 40 CSOs, 80 staff members working with citizens and targeting marginalized communities, elderly, people with disabilities (PwDs), rural households, women, and vulnerable youth, in the project's geographical area.

Overall objective:

CSOs are effective independent actors that contribute to inclusive digital transformation and enhanced democratic space in Mongolia in line with the Digital Nation strategy of the Government of Mongolia.









Project Output 1

CSOs and NGOs working with targeted groups will acquire the necessary skills and resources to ensure their organization's cybersecurity and adapt to changes. Additionally, by working with targeted groups, they will master the ability to eliminate the root causes of the digital divide.



CSO internal organizational capacity development

Workshops, technical methodology advice, and mentoring activities will be conducted for selected CSOs on the opportunities of digital transformation, digital risks, and security issues.



Capacity Development to Lead Citizens Digital Literacy Activities

Through digital technology, increase citizen participation in the democratic process and enhance the digital and literacy education of targeted groups by training trainers from NGOs.



CSO-led Actions to Strengthen the Digital Skills of Citizens

Initiatives and activities of NGOs aimed at increasing public participation in the digital environment and enhancing citizens' digital and information literacy skills will receive small grant.

Project Output 2

Strengthening the ability of CSOs and CSO networks working in the digital policy sphere to address the digital divide at policy level in collaboration with government stakeholders.



Inclusive Digitalization Advocacy Roadmap

Research and development of practical guidance to facilitate a stronger legal framework for digital transformation and support the effective participation of CSOs in shaping inclusive digital policies and digital governance frameworks.



Support to CSO Networking, Advocacy, and Joint Policy Dialogue

Capacity development and support to CSO participation in joint policy formulation, policy dialogue monitoring and tracking of inclusive digitalization policies / regulatory frameworks.



CSO-led Policy and Advocacy Actions with small grant

Small grant for CSOs and CSOs networkled policy dialogue and advocacy actions to support inclusive digitalization policies, monitoring of policy dialogue, legislation and regulatory frameworks.
